PRIVACY POLICY

Welcome to Bewell. This Privacy Policy applies to our website at https://bewell.vn, the Bewell application (collectively referred to as the "Platform"), and related services, including online healthcare advisory services, the Bewell care chronic disease management program, and medication advance services (collectively referred to as the "Services"). Bewell is operated and controlled by Bewell Joint Stock Company (referred to as "Bewell," "Company," or "We").

Protecting personal data, building trust, and continuously improving user confidence are paramount to us. We are committed to safeguarding and respecting the privacy rights of our users and adhering to the provisions outlined in this Privacy Policy when handling user information. This policy explains how we collect, use, share, and process personal information when you use Bewell's Platform and Services. I. INFORMATION WE COLLECT

1. Information You Provide to Bewell

Profile information: When you create a Bewell account, we collect information such as your name, email address, password, date of birth, gender, phone number, and any additional details you provide in your profile. You can also add profiles for family members.

Contact information: You may provide us with information through chat or video chat systems, medication advance requests, prescription and non-prescription medication purchases, purchases of other products on the Platform, email, or other means. This includes personal details like your name, date of birth, gender, address, delivery address, phone number, and email. It also encompasses documents and information related to consultations, purchases, and use of our Services, such as prescriptions, examination reports, symptoms, medical treatment recommendations, and insurance details.

2. Information We Automatically Collect

Location information: With your permission, we may collect precise location data when you use our Platform and Services to help you find the nearest pharmacy.

Device information: We collect information about the devices and software you use to access our Platform and Services, including IP address, web browser type, operating system version, phone manufacturer, installed applications, device identifiers, timezone settings, and advertising identifiers.

Usage information: We automatically receive data about how you interact with our Platform and Services, such as pages or content viewed, any content you submit, and the times and dates of your interactions.

Image and audio information: We may collect video, image, and audio data when you use our Services, including identifying objects, scenes, faces, physical attributes, sounds, and spoken language.

3. Information We Receive from Other Sources

Social media accounts: If you choose to register or log in to the Platform using your social media account (e.g., Facebook, Apple, Google), we may collect information such as your username, public profile information, and other details associated with that account.

Publicly available data or from authorized state agencies: We may receive information about you from public sources or government agencies, including mentions or references in direct messages, complaints, objections, requests, or feedback sent to us.

II. HOW WE USE YOUR INFORMATION

We may use your personal information for the following purposes:

- To Provide Services: To communicate with you and deliver our Services, including sharing your information with healthcare advisory service providers, medication providers or pharmacies, and payment service providers as needed.
- 2. **To Operate and Improve our Services:** To manage, monitor, and enhance our Platform, including troubleshooting, data analysis, testing, research, statistical purposes, surveys, and gathering feedback.
- 3. **For Customer Support:** To address inquiries, suggestions, and complaints to improve service quality, and to conduct statistical analysis to develop and enhance our services based on your needs.
- 4. **For Security Purposes:** To maintain Platform security, protect your safety, verify identity when necessary, and prevent abuse, fraud, spam, and illegal activities.
- 5. **For Marketing and Communication:** To send promotional materials and communications about Bewell through the Platform, messages, or email.
- 6. **Legal Compliance:** To respond to legal requests, court orders, legal processes, and fulfill our legal obligations.
- 7. **Other Purposes:** With your consent or as otherwise permitted or required by law.

III. SHARING YOUR INFORMATION

In general, we do not share your personal information with external parties outside of Bewell. However, we may share your information in specific circumstances, such as:
